manner that will create positive energy for all family members, that I will assist my sister wives in acquiring the skills necessary to contribute to the positive energy of our family unit, that I will assist my sister wives in all matters regarding their family duties and obligations and that I will assist all members of the family in their spiritual growth in any manner that I am capable.

I, _____, do hereby attest that I understand that this agreement can only be broken by the publication and recording as a Public Notice of a Publicly Proclaimed Deliberated Revocation of Male-Female Partnership Agreement and that upon my action to revoke this agreement I will knowingly, voluntarily and intentionally relinquish, forfeit and abandon my parental rights and my claim to any monetary and or material property within the family unit with the understanding that my husband, male partner, may at his discretion bestow monetary and or material possessions on my behalf; furthermore any visitation with my biological children and or any other members of the family will be solely the decision of the head of the family unit; and that this Revocation must be witnessed by two people.
